Darin Forbes- This is not anything we have to act upon, but they would like to see if maybe, just like we did with the AuSable River Association thing, we could form an exploratory committee just to start looking at some options and get some ideas on the table so when we decide to act upon it we will have some ideas. That's what they are looking for at this point.

Steve Corvelli- The biggest issue, especially in this Town is enforcement.

Darin Forbes- I don't see a downside at least getting some ideas together and I think one of the things that is important and we should probably implement first is permit process because people are put in private houses and the building inspector hasn't been there in 20 years. We don't want our Town where something happens where a family burns up because of no process to check on the lack of smoke detectors. I think it is important to at least do a bi-annual inspection of everyone that is registered with the County. We could have just a simple check list for the building inspector to go through. It could be a very simple permit process. We could charge a low fee for it. That should be one of the first things we do because now we have nothing. We are not telling anyone no or yes basically once you are registered with the county you have to register with the Town and we have to go in and inspect the building before you can do it. Town has a obligation.

Steve Corvelli- Its more of a registration than a permit. So we can have our Code Enforcement officer check for safety issues.

Dawn volunteered spearheading putting together a committee with Allison Livesey. Would like at least five people on the committee.
