Re: Dog Attack Town of Wilmington

Dear Sirs and Madams:

I am writing this letter to bring to your attention a matter of public safety so the Town Board and appropriate town officials will take the necessary steps to rectify this serious situation. It is my understanding that on December 20, 2021 our neighbor, John Langford, was jogging on Haselton Road and was attacked by the large German Shepherd owned by Tom and Jonathan Sibalski, residing at 1333 Haselton Road, Wilmington NY. Below is a summary of my experiences with this same animal and the actions taken by the Town of Wilmington (Town).

On September 2019, I was performing yard work on my property. My property is located at 1321 Haselton Road and is adjacent to 1333 Haselton Road. During this incident, the dog left the Sibalski property and came onto my property. The dog was acting aggressive, barking, and snarling at me. I was frightened and fearful for my safety. Jonathan Sibalski arrived and retrieved the dog. This matter was brought to the attention of Shirley Lawrence.

On October 20, 2020 Joseph Grigely, a guest at 1321 Haselton Road, complained to me that he and his dog attempted to go outside via the front door of the cabin but stopped when they encountered the Sibalski dog slowly approaching up the sidewalk leading to the front door. Joseph retreated to the safety of the house and took a picture of the dog. He was quite upset by the incident and felt the dog was in a stalking stance and acted if it may attack. This incident and the photo taken at the time were presented to Shirley Lawrence along with a request that the Town take appropriate action.

On January 2, 2021 Roger Bonner, my partner who resides with me, was snow blowing the driveway at 1321 Haselton Road. Roger was riding a subcompact tractor and was wearing hearing protection. He did not notice the Sibalski dog that had come up to the rear of the tractor. The dog was snarling and barking and, had he not been on a tractor, felt confident the dog would have attacked. Roger

was yelling at the dog to leave my property when Tom Sibalski began yelling at the dog to return to his property. The dog did not respond to any verbal commands. Tom then came onto my property and tried to physically take control of the dog. The dog continued to bark, act aggressive, and tried to free himself from Tom's restraint. The dog continued to bark and jump towards Roger as Tom pulled him back to his property. Immediately following this incident, Roger contacted Roy Holzer, Shirley Lawrence, and the officer on duty at the local New York State Trooper's barracks. Later that morning, Roy Holzer met Roger at the scene of this incident so that he could view first hand the tracks in the snow showing dog prints leading onto my property and the those of Tom Sibalski and the dog returning to his property.

- As a result of the September 2019 incident a letter was sent from the Town to Jonathon Sibalski that states in part, "If this continues you may be summoned to appear in court and answer charges that you are in violation the dog control law."
- As a result of the January 2, 2021 incident a letter was sent from the Town to Tom and Jonathan Sibalski stating in part "Should we receive another complaint, paper work will be filled out with the local court to answer the charges."
- It is unknown whether the Town took any action concerning the October 20, 2020 incident.
- According to correspondence from the Town dated March 19, 2020 there were two other complaints about this dog being walked on Haselton Road without a leash. This letter states in part "If this continues you will be summoned to appear in court and answer charges that you are violating the dog control law..."
- It is my understanding that, besides John Langford, this dog has bitten two other individuals. This information should be on record with Essex County, as they are required to document animal bites requiring medical attention.

It is clear the owners of this dog are either unwilling or unable to properly control this animal. I am respectively requesting the Town take immediate and appropriate steps to protect the safety of the people of this Town. I feel in the past, the Town has not taken this matter seriously. I believe if the Town refuses to take appropriate action, future attacks by this dog will occur which may result in serious injury, maining, or worse. I feel the Town has a legal obligation to act on this matter in a timely fashion.

I am requesting this letter be read into the minutes of the next regular Town of Wilmington Board Meeting. If you require further information please let me know.

# 200th anniversary of the Town of Wilmington, New York

**By:** Town Supervisor Roy Holzer and the Wilmington Historical Society

## Commemorating the 200th anniversary of the Town of Wilmington New York

WHEREAS, is the intent of this board is to honor and commemorate the distinguished history of the town of Wilmington which comprise of noble body of this great state of New York and Essex County; and

WHEREAS, attendant to such concern and in full accord with its longstanding traditions, this legislative body is justly proud to commemorate the 200th anniversary of the Town of Wilmington, Essex County, New York; and

WHEREAS, currently town of approximately 1300 people Wilmington was created by the State Legislature on March 22nd, 1822, establishing the town of Wilmington as a separate entity from the town of Jay in 1822 while having been taken off from the Town of Jay in the prior year as Danville, was renamed and held its first official board meeting as Wilmington in April 1822: an

WHEREAS, Wilmington lies between the towns of Saint Armond and on the West and Jay on the east, on the northern border of Essex County in the High Peaks Regions of the Adirondack Mountains with the West Branch of the AuSable River flowing in a northeasterly direction nearly through the center of the town; and

WHEREAS; the topographical aspect of Wilmington is seen to be rough, elevated, and mountainous, with long slope descending to the AuSable River and its tributaries which presents a varied end picturesque scenery with a majestic Whiteface Mountain overlooking the region at a height of 4867 feet above tide and from those summits can be had one of the finest views of in Northern New York; and

WHEREAS; the West Branch of the AuSable River has historically provided mechanical power, log transportation, world class fishing and tourism opportunities including the spectacular High Falls Gorge; and

Whereas; pioneer families began settling in the Wilmington area in about 1800, the earliest settlers being Reuben Sanford, Cyrus Wilson, Isaac Peck, Allen Peck, Ruben and Daniel Hamblin, Daniel Ray, John Blanchard, Z. Gray, and Nathaniel Warner; and

WHEREAS; when the War of 1812 was declared Wilmington (then part of Jay) provided militia for the war effort; and

Whereas; in 1814 major Reuben Sanford leads four companies of militia from the Towns of Jay, Keene, and current Wilmington at the Battle of Plattsburgh becoming a war hero in that battle when he kept the British from crossing a Plattsburgh bridge by cutting the stringers of the bridge while under heavy fire, one of the volleys actually striking the axe he was using to chop the bridge tempers; and

WHEREAS; after the war Rubin Sanford represented the district in the New York State assembly from 1814 through 1817, was a delegate to the New York State Constitutional

Convention of 1821, was a member of the State Senate for four years being elected in 1828; and

WHEREAS; Reuben Sanford was instrumental in establishing the Town of Wilmington as a separate entity from the Town of Jay in 1822, became its first Postmaster, served as Town Supervisor for two years, contributed to the construction of the Methodist Church of Wilmington which still stands today, erected the first store, which made him the mightiest pioneer in the Town of Wilmington and one of the most prominent men in the Northern New York; and

WHEREAS; preliminary a residential and tourist-centered community today Wilmington was once a farming, iron mining, lumbering and industrial community with a potash and starch factories, sawmills, gristmills, and whisky distilleries; and

WHEREAS; through its history, residents of Wilmington have responded to serve the nation during times of war and conflict, including BUT not limited to, the Civil War, Spanish American War, World War One, World War Two, the Vietnam War, The Gulf War, The War in Afghanistan, The Iraq War and the War on Terror, and

WHEREAS; notable citizen Henry Harrison Markham, born in Wilmington, Essex County, New York, November 16th, 1840, attended the common schools of his hometown, served in the Civil War, studied law, and was admitted to the bar in 1867 served in the 49th Congress March 4th, 1885, through March 3rd, 1887, and became the Governor of California 1891 through 1895; and

WHEREAS; notable citizen, Reuben L. Partridge, born in Wilmington, Essex County, New York in 1823, attended the common school of his hometown, moved to Maryville Ohio in 1836, learned the carpentry trade, and received a patent for his truss designed of self-supporting covered bridges, having built over 125 in his lifetime; and

WHEREAS; early hotels such as the Whiteface Mountain House and the Hotel Olney established recreational opportunities for developing tourism leading to today's wide range of outdoor activities and attractions including BUT not limited to, Whiteface Mountain, Whiteface Mountain Ski Center, Whiteface Veterans Memorial Hwy, Santa's Workshop, High Falls Gorge and World Classified Fly Fishing; and

WHEREAS; Wilmington and Whiteface region activities include scientific research, fishing, hunting, camping, hiking, paddling and biking just to name a few, all within proximity of millions of people; and

WHEREAS; Wilmington was the venue for the 1980 Winter Olympics Alpine Events and continues to host National and World Class Ski Competitions; and

WHEREAS; Wilmington has evolved from its rural roots into an outdoor recreational, science, and educational destination featuring its natural attributes and the unique blend of natural resources, a touch of wilderness, entrepreneurship, and personal enterprises which has created a small rural town of national and international acclaim; and

**RESOLVED;** that this Legislative Body pause in its deliberations to commemorate the 200th anniversary of the Town of Wilmington, New York, recognizing the significance of the role it continues to play in the life of the community/communities of the Town, Essex County and New York State; and it will be further

**RESOLVED;** that a copy of this resolution suitably engrossed be placed in the official minutes of the Town of Wilmington, New York.

### 8-2022 Resolution

Whereas: North Country LIFE FLIGHT Inc. is a not-for-profit, tax-exempt corporation which is responsible for all aspects of patient care by providing medical equipment, training medical personnel, and administering the medical portion utilizing the New York State Police helicopter based in Saranac Lake and private fixed-wing aviation resources; and

Whereas: The New York State Police aviation resources do not provide a medically trained team or medical equipment for patient transports; and

Whereas: The people of Clinton, Essex, Franklin, Hamilton, and St. Lawrence Counties receive a vital emergency medical service for critically ill and seriously injured patients, and therefore municipal governments are asked to pledge monies for this worthwhile program;

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Wilmington hereby authorizes the Supervisor to enter into a contract with North Country LIFE FLIGHT, Inc. for the purpose of operating the medical component of the medevac program, which will serve its residents and visitors, and paying the amount of \$250. which represents the Town's share for 2022; and be it

FURTHER RESOLVED: That the sum \$250. is hereby appropriated to Account No. for payment to North Country LIFE FLIGHT, Inc.

The camera system is up and running on the Whiteface Memorial Highway/431. This system will help the highway department to be more efficient with snow maintenance. The system is very easy to use and looks very promising. The weather on this road can greatly differ from the weather in town.

The contract with the Town for the Visitors Center expired last August, this was a 20-year contract. With the Pandemic going on it was almost overlooked. Michelle Preston on behalf of the Bureau asked the lease to be extended till January 1, 2023, so that both parties can explore options and come up with a fair lease.

There was a discussion between Michelle Preston and the Board. It was agreed that the Marketing Agreement and the lease should be a combined document. It was also agreed that the Visitors Bureau is a great partner of the town as is the Fire Department and the library.
