Darin talked to Greg Winch about continuing as Sexton of the Cemetery's on a part time basis. Greg agreed if the Town puts some work into it, otherwise he is gone. He will not dig the graves. When his replacement is hired he will start on the new section. Board agreed to take the \$20,000 from the sale of the land to the Hospital and update the Cemetery's. Supervisor will contact Doug Nemeck to see if he is interested in working at an hourly rate to try straightening the Cemetery's out.

Assessor position- Doug Smith, Doug Nemeck and Marcel Bruce are interested in the Assessor position.

Highway department is due to get a new tandem truck to replace the 2010. There is a thing called mini bid which is like a state contract, we do not have to go out to bid on this. They are giving us \$30,000 for the 2010 truck that we are trading in. The price estimate for just the truck is \$213,000. The last truck purchased was around \$130,000, it was about \$220,000 for everything. The box, plow and lights will be another \$80,791. Board decided to create a spec. and put it out to bid. Tabled for now.

Led Lights- we have to buy the arms and the fixtures from NYSEG then the led lights get installed inside of it. There is grant money to reimburse, but you have to go through the process first. We need to get a price on the arms and light fixtures from NYSEG. The payback on all of it is like 7-8 years. We are saving a lot of money yearly on the use itself.

Highway got a new pickup.
