RESOLUTION 36-19 TOWN BOARD APPROVED THE JUNE 11, 2019 MINUTES.

Karen Peters gave a presentation on the future historical building that will be located on Route 86 near the A & W Restaurant.

Dam Update- The Construction crew has finished everything, but the gate construction. The Town crew put the boards on today so we have a full river for the first time in two years. Bill stated that when the Construction crew built a small temporary dam they put re-rod in the pin holes used for the boards and then instead of removing them they cut them off even with the top of the hole. Bill had to drill new holes.

High water tore Larry Hegele's dock from his property and it caught at the dam. The Construction crew removed it from the dam and put it on the bank which is Town property. Bill will notify him and have him come and get it.

Raft and Dock will go in at the Beach tomorrow.

Public Comment- It was thought that the garage Jarrell Barton (code Enforcer) is building is against Code. It was recommended that a bordering Town code enforcement check it out.

Ed Orsi says the top of the dam at the reservoir did deteriorate and needs to be repaired. Ed got 3 quotes Luck Brothers bid \$9025.00 Rene's Construction bid \$10,000 and Derrick Hackett bid \$3,800 (he works alone on his own business and doesn't have to pay prevailing wage.) Ed recommended Hackett at \$3,800.

RESOLUTION 37-19 TOWN BOARD ACCEPTED THE BID FROM DERRICK HACKETT MASONARY TO REPAIR THE RESERVOIR DAM FOR \$3,800.
