The Town Board wishes to appoint Lou Adragna to the position of Highway Superintendent for this calendar year only. His salary will be prorated to reflect the budgeted salary for Highway Superintendent. Lou will retain his current position of Heavy Equipment operator until 12/31/2020.

For the purpose of this agreement, Lou will accumulate sick time as an employee of the town while serving as Highway Superintendent, in the event he is elected Highway Superintendent, all sick time credited in 2020 will be forfeited. His current sick time of 618 hours can be used upon retirement to off set health insurance cost per town policy. This cannot exceed 6 months. Retirement means receiving a New York State Retirement Check for the purposes of this agreement. Personal leave will not be accumulated or credited for 2020.

Lou can accumulate vacation time per established guidelines for 2020. How ever, in the event he is elected Highway Superintendent, no time will be credited or paid for 2020 and is forfeited. The Vacation time of 80 hours that Lou had already accumulated prior to the appo8intment will be paid for in December 2020 in the event he is elected Highway Superintendent. The value will be at his 2019 hourly pay.

Supervisor Holzer discussed the possibility of a waste water sewer system for economic development for the Community. It is not for the whole town, it would be just for a separate sewage system for a couple big projects. Whether it be a Hotel, housing development Etc. We are still in the very preliminary stages of this. The Town was awarded a grant to buy the land for it, we just don't know how we are going to pay for it because the actual tank itself could run to 3-4 million dollars. If The Town gets a big development or Hotel the Dec. or APA would probably demand it. It is not a plant itself it is two big holding tanks that all the gray water will go from your place to the system. You would be responsible for your solids. It is like a gray water treatment area. This would not affect any existing businesses. If a Hotel was built in the Town that Hotel would pay for most of the bill. Chances of a Hotel probably will never happen.

Supervisor Holzer will have a town audit soon. There hasn't been one in over 10 years.

PUBLIC INFORMATION- SHORT TERM RENTALS - we started working on draft copies of our amendment to the Town of Wilmington land use code pertaining to short term rentals. Copies are available at Town Clerks Office. It is very preliminary right now, the Town Board is just starting to read it and open to suggestions. We had our Town Attorney Allison McGahay read it to make sure we are legal and all that. The public will have plenty of opportunity to read it and make suggestions to the board.
