2021 town budget has been submitted to Jerry Bruce/Town Clerk. We are under the State cap on what they allow us. In preparing the budget one of larger increases is we were expecting a half of a million dollars of re-imbursement on the town dam project. The economy being as it is we are still waiting for the half Million from the State. We still have to meet the obligations even though part of it is a grant. Budget went up about 4 cents per Thousand.

The Town has to do a public hearing on the budget. We have to do it by November 11<sup>th</sup>. Board decided to have the public hearing and the regular Town Board Meeting on Thursday November 5<sup>th</sup> instead of our regular time of Tuesday November 10<sup>th</sup>.

NYS Agriculture & Markets contacted the County on S.P.C.A. not being equipped to handle dangerous dogs, like pit bulls that have to be put someplace that is secure. That was the section that the S.P.C.A. didn't pass. More Towns in our county is doing until S.P.C.A can accommodate the placement of dangerous dogs is enter into an agreement with Eagles Nest Veterinary Hospital

In Plattsburg. . If we get a dangerous dog we are responsible for room and board for that animal. Then the Courts go after the owner of that animal to collect and reimburse the Town. We are obligated by law to have this.
