She invited everyone to start coming to the meetings so they know firsthand what is happening in the town and can ask questions. Several individuals spoke in favor of Michelle Preston. Rarilee Conway stated she wrote her letter before she was aware that Michelle Preston would accept the appointment if the Board desired. She stated she was in full support of Michelle. Stephanie Gates spoke on her own behalf and stated she would be filing a petition to run in the next election. Everyone who wanted to speak ,spoke.
