Public Hearing on junkyard application

The meeting was called to order by Supervisor Holzer at 5:00 pm.

Bruce Huntington explained to the Board and the residents at the meeting why he was seeking a license for the junkyard. Mr. Huntington explained that the need for the Junkyard was only temporary. It is his only course of action after a tenant was evicted and did not take his possessions. Most of which, were cars, boats, and Snowmobiles along with a lot of work equipment. Mr. Huntington stated this was the only way he could charge for storage of the numerous items left behind. Mr. Huntington also asked for a variance on the fence since this was only a temporary Junkyard that would no longer be in operation after this problem was resolved.

Supervisor Holzer stated if the application was approved it was only for one year. If an extension was needed a fence would be required.

Ed Hood read a letter that gave the pros and cons of this application. He also stated that he understood the reasoning behind the application. Mr. Hood suggested the town review the ordinance and make updates to it.

Resolution 104-2022

Resolved; authorizing a Temporary Junk Yard Permit to Bruce Huntington at property located at 46 Fox Farm Road. The permit is given with the condition that Legal counsel for the town is comfortable with all ownership/trust requirements, Permit is for a one-year period from the date of the permit issuance, and the landowner agrees to a one-year period, if for some reason it goes beyond a year, a fence will be built completely surrounding the area. The landowner agrees to allow Wilmington Codes Enforcement on the property at least every 2 months to monitor clean-up, no new materials may be added to the junkyard.
