**BE IT RESOLVED**, that the Public Hearing was held on November 9,2023 at 6:30 pm o'clock in the afternoon to hear any and all persons concerning the adoption of said local law: and

**BE IT FURTHER RESOLVED,** that the Town of Wilmington Town Board hereby adopts proposed Local Law No. 3 of 2023 entitled "A Local Law To Override the Tax Levy Limit Established in General Municipal Law §3-C," reading and provided as follows:

# Town of Wilmington Local Law No. 3 of 2023

A Local Law To Override the Tax Levy Limit Established in General Municipal Law §3-C.

Be it enacted, by the Town of Wilmington Town Board as follows:

Section 1. Legislative Intent.

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Wilmington, Wilmington, pursuant to General Municipal Law. § 3-C, and to allow the town of Wilmington to adopt a budget for the fiscal year 2024 that requires a real property tax levy in excess of "tax levy limit" as defined by municipal law § 3-C.

### Section 2. Authority.

This local law is adopted pursuant to subdivision five (5) of General Municipal Law, § 3-C. Which expressly authorizes the town board. To override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

### Section 3. Tax Levy Limit Override – Budget Authorization.

The Town Board of the Town of Wilmington hereby overrides the tax levy limit for the Town of Wilmington for 2024 and authorizes the Town of Wilmington, after completing all required procedures for the adoption of a budget, to adopt a budget for 2024 that requires a tax levy that is greater than the tax levy limit calculated for 2024 pursuant to § 3-C of the General Municipal law.

### Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof. To any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair., or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law, or in its application to the person, individual, form, or corporation., or circumstance, directly involved in the controversy in which such judgement or order shall be rendered.

### Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
