Thanks to all the volunteers that made the 16th Annual Wilmington Christmas Celebration such a great success. The event was awesome, and I really appreciate the participation of our town staff that work so hard on our yearly event.

Also, a sincere thank you is extended to all the people and businesses that donate to our celebration. Between Fireworks and gifts, our yearly expense is around \$10,000. All done with donations. Currently we already have around \$5,000 towards next year's event.

Speaking of Christmas, we will once again be participating in the "Toys for Tots" program this year. Next week the back tables will be full of toys for our younger citizens. Anyone in need can contact the Supervisors Office. All assistance is handled with strict confidentiality.

I have been notified by NYSEG that there will be a brief power outage on December 13th at 9am.

I would like to offer a resolution to approve registration, training costs and expenses for any newly elected Wilmington officials to attend the New York State Association of Towns training classes to be held in January.

The Town of Wilmington has officially been designated a Clean Energy Community by NYSERDA.
