3. Anyone with proof of previous vaccination is asked to snap a photo & email it to [health@essexcountyny.gov](mailto:health@essexcountyny.gov). All others will be given a 1 year certificate. Those that bring proof of prior vaccination (certificate) will be mailed a 3 year certificate.

Bring the most current vaccination certificate for your pet. Tags are unable to be accepted as proof of vaccination.

### First Time Vaccinations

Required for pet dogs, cats & ferrets by 4 months of ages per NYS Law\*Expire in 1 year  
\*All pets must be at least 3 months old.
